

Audit Committee Report 2021

2021 Financial Review

Jan to June 2021 general ledger was reviewed. We reviewed classifications of entries. All June expenses were reviewed and traced to specified accounts. Compared year to date revenues vs prior year and found no significant issues or differences. Reviewed existing financial policy and procedures.

Comments and Recommendations

- 1. Update financial policies and procedures. Last update was in 2013.
- 2. Consider having a outside accounting firm evaluated the WPC financials and provide a template for future audit committees to standardize.
- 3. Consider/evaluate/update digital technologies for financial and transactional interactions. Ex digital wallets, digital payments, electronic accounts, and digital reporting practices. What features does current software offer in this area? How can we monitor and approve, for example, payments made using applications like "Apple Pay", "Google Pay" or any other digital wallet and/or payment features?
- 4. Identify possible digital and cloud technologies to make reports and transactions easier to view, track and reduce expenses.
- 5. Review existing financial software vs competitive providers.
- 6. Evaluate feasibility of digital technologies such as DocuSign for expense reporting and other applications.
- 7. Expense reporting: meals- include meeting purpose and any attendees

This audit is not as thorough as a traditional audit, we feel that the sample evaluation of receipts and financials provides reasonable assurance that the reported amounts are accurate. As noted, the committee recommends an outside firm provide a periodic review of WPC financials.

I am pleased to report that 2021 was financially a very good year for us. In terms of our budget for the year, our revenues were 6% higher than the forecast, whereas our expenses were 4% below our expectations. Stated differently, we expected to end the year with a modest surplus of \$10,000, instead our surplus was a little over \$71,000. We have had a long tradition of "If you donate it, we will spend it." Generating a healthy surplus gives us more flexibility going forward.

This year we have made significant changes in the cash management of our funds. In August we condensed our operating accounts to just two: a checking account and a portfolio account. Both accounts are at Centier Bank with whom we have had a longstanding relationship. We are able to move funds back and forth between these two accounts as our needs require. Our target balance in the checking account is \$100,000 with the remainder invested in the portfolio account. The portfolio is structured as a conservative investment strategy with approximately 65% in fixed income and 35% in equities. We are intentionally spreading the investment of the funds over a period of time and currently 30% of the account is in a money market. In the four months we have had the portfolio account in place we have generated approximately \$2,850 in interest and dividends. Once we are fully invested, we expect to generate about \$10,000 per year in interest and dividends, and another \$10,000 in capital gains for an anticipated annual total return of \$20,000 or about 4%.

We have also activated our \$150,000 line of credit with Centier. The line of credit provides us with a "safety net" in funding our various missions without delay. So far, we have not borrowed any money against the line of credit.

2022 Annual Report Associate Pastor of Youth and Christian Education

At the beginning of 2021 I was still the Associate Pastor of Youth and Mission. Our services were all online, and Loaves and Fishes was attempting to organize and restructure after Nicole retired from leading the organization.

Loaves and Fishes worked hard to organize and work on team leadership rather than having a single person responsible for everything. We maintained the ship and held our own for the days we were feeding the shelter and picking up food. I think things have taken a turn for the better since Ginny has taken over leadership of Mission and guiding the Loaves and Fishes group.

Youth Ministry was primarily online, we ran a church Minecraft server which may yet return. We also held bi-weekly dungeons and dragons games online, until August.

Our Senior Sunday service was a week early, due to the school's scheduling of the ceremonies during services but we had a lovely message from our seniors who spoke.

Over the summer we held confirmation and added two new members to our roster, Lars Grow and Cole Eplawy. Jackson, was a member of our classes but joined his home church of Immanuel Presbyterian in Schererville.

In July I was put in charge of Christian Education. Thankfully Ken maintains strong leadership of the Westminster Forum, and our adult learning hour at 9:00 AM has willing and able volunteers. We made the conscious choice to keep our children in worship, and move Sunday school to 10:10AM between services. We have seen a large number church children joining together in class from both services. Our curriculum is the Dwell Flex program, designed to offer thought provoking questions encoring our children to learn by growing in their curiosity and wonder of the text.

Youth programming took off in September with monthly events, weekly youth group, volleyball practice, and bi-weekly dungeons and

dragons. Youth group is a time spent looking at the scripture for the up coming Sunday, and having fun. Volleyball practices is in anticipation of our annual inter church volleyball league, which should be going on right now, we also have a time for bible study and dinner when we are done practicing. Our bi-weekly dungeons and dragons groups is a wonderful time for fellowship and fun as we explore the magical world of the Forgotten Realms. Our church continues to grow welcoming new youth to different events, each student attending things they enjoy. We did our annual apple picking and pie making and delivering. We used bake at home kits again this year and I felt that went quite well.

We started up family ministry events again with a movie on the lawn. Even though the show ended with the sprinkler system rising up from the ground and spraying us all, nobody was hurt and no equipment was damaged. We did however learn our popcorn machine was broken, so a new one was ordered.

We had a fabulous Trunk or Treat on Halloween Sunday in 2021. We had over 400+ participants, and the ambulance company even showed up to celebrate halloween with us. It was a great event, where we learned many notes for next year including preparing extra candy for everyone!

The November Late Night/Overnight was successful. We had a great 3 hours packed with fun games and activities. Our Middle School students went home at 10:00, much to their dismay, and our High Schoolers attempted to stay up all night! Many valiant attempts were made, but thankfully everyone got a little sleep before breakfast in the morning.

Bethlehem Marketplace was all outdoors this year and though it was different from our past experiences I loved it. The children did a great job with the show and working the food booth. It was a wonderful time shared with our church and community. We also raised good money for youth events and for mission ministry.

We capped the year off with our annual youth Christmas party. It was a great time of pin the baby on the manger, Christmas ornament making, and of course a white elephant gift exchange. The party was an absolute delight and a great way to end our youth activities for 2021.

Building & Grounds

Another year, another annual report comes due to the members of WPC from the building and grounds department.

Thank you to Gina for helping our department out and working with me and more importantly communicating with me any questions that come through her from the congregation. Not only to be willing to help but able to do so with confidence and knowledge is something personally, I strive for at the church. Keeping myself aware of all activities and usage at WPC is important and healthy in case anyone asks what is happening or if we have events or items for use at the church.

Blood Drives January, April, July was held without incident, and had wonderful attendance during each one. We are scheduled for 4 this coming year (January, April, July, October.)

Scouts of our own Troop 219, were able to use our facilities mostly in warm weather; they used our storage building aka garage on Monday nights. Also on Wednesday evenings the scouts from troop 533 used the garage area and parking lot for their meetings. Once the cold weather came to our area Troop 219 used our South Hall using masks and taking precautions for social distancing. A thank you for the springtime help from all the scouts that helped do some yard work and mulch moving for us in our springtime cleanup of the church property.

Thank you, Jean Dixon for your help on the outside projects.

Also, Troop 219 helped with the color guard for our 4th of July outdoor service.

With the springtime and most of the summer of us using the outdoor lawn and front parking lot for church service, it was nice to get back into using the building and sanctuary. Working in conjunction with the task force and the others we could provide a safe and clean environment for worship and semi fellowship at the church.

Early March the sink-hole appeared and after a summer with the hole we got it covered in late October and finished in November, the project ended up being a smaller amount than initially quoted, Mike Moses has more information on the particulars, thank you to him and Tom Ogren for working on that issue.

Building and grounds used Matt's Landscaping for the lawn cutting and bush trimming and fall clean up.

Purchased a Carpet Extraction machine.

Brandon Hicks left in August 2021, we thank him for his service. We continue having Ray and welcomed Lisa, Rossi, and Martin into the fold as workers for the department.

Communication with Preschool and specifically Tricia the director was key working back to last winter and spring getting us through school season, we are given a calendar well in advance so we continue to have all the information needed to plot out the calendar year.

Working with Austin and Loaves and Fishes to help facilitate the coming and goings of the kitchen and helping with the Tuesday donations with St James. We had to replace the condenser unit for the walk-in freezer this past year. The shipping delays of the spring and summer caused a delay in getting the parts needed. Continued working with and in conjunction with Ginny as she took over in August of that department.

Vanessa thank you for getting more info out and working with her to update and add new signage and a more valuable cost to keep all informed. Also helped her and Ginny out with the printer connections and getting their department computers updated with the proper drivers and printing software for our copy room Konica/Minolta machine.

Cleaned up multiple rooms created a storage unit room making 5 other areas clear of clutter. Still working on it but getting results in the attic area. Especially after holidays where we are able to label and put in designated areas the items that are salvageable.

The garage area has been organized some more and will be a focal point this coming summer. Air conditioning units updated and connected. Furnaces filters were checked and replaced throughout the property. This past year we also had our biannual inspection per state code for our water boiler in the choir loft area. Gutters cleaned and marked for next year for repairs on some of the joints just part of aging and maintenance of a building. Electric panel with light switches in South Hall installed and utilized wonderfully with a timer for the overhead light. The kitchen in south hall lights arrived during the year, we are targeting a time to get into the kitchen area and put the fixtures in place. Setting up, taking stuff down, cleaning, organizing, facilitating helping out is what the department of building and grounds aims to do each day, week, month and year.

We have a lot going on even when the church was "closed" during the early part of the year, our property and buildings need care and keeping after, that is what our team does. I look forward to many years of continued service to WPC.

LOVINGS HANDS 2015

We are a group of about two dozen women who knit and crochet for mission. We come from half a dozen local churches and meet on Mondays at 12:30 in the Lounge near Fellowship Hall. Much of our hand work is done between meetings at our individual homes.

This year we donated 504 knitted and crocheted hats, 211 scarves, and 92 pairs of mittens to 6 local elementary schools in Hammond, East Chicago, and Lake Ridge. We gave 51 lap robes and 8 shawls to nursing homes in Whiting and Dyer. We provided 77 hats and 24 scarves to homeless shelters in Gary, Hammond, and Oak Lawn. We gave 52 baby blankets, 130 other baby items to St. Monica's home. Westminster's Health and Healing Ministry received 4 prayer shawls and 2 baby blankets. We supported Sojourner Truth House in Gary with 52 hats, 22 scarves, and 2 pairs of gloves for adults and 19 baby hats. The Westminster kitchen received 28 potholders. We sent 12 preemie blankets, 16 preemie hats and 4 pr. booties to Porter Regional Hospital and sent 8 purple newborn hats for the shaken baby project at Parkview Regional Hospital. We also provided 34 hats, 33 scarves, and 6 pairs of gloves to others in need.

The group is always appreciative of donated yarn. We'll put it to good use.

MISSIONS 2021 REPORT

Happy New Year (I think...)!

2021 was a year unlike most in our lived history and challenged us to love our neighbors in brave, new and even uncomfortable ways. Our church staff and committee leaders have worked tirelessly to learn new ways of operating and connecting in a pandemic while navigating ever changing information and expectations. We've hoped for the best and planned for the worst. And most importantly, we've endured and continued to grow in our mission efforts as a Matthew 25 church. Through our budget alone we've supported 15 organizations across a spectrum of initiatives and that's just our starting point.

On the Loaves & Fishes front, we've renewed our relationship with Hammond City Rescue Mission and are now providing meal support 3 days of a week. We also were able to provide a tremendous Thanksgiving meal, new boots and shoes as Christmas gifts for the men this year, and New Year's Eve meals. Thanks to all our pickup volunteers efforts, we're also taking in more food than we can use. We've been sharing overflow donations with our congregation on Sundays, St. James food pantry, the United Methodist food pantry, Greater Hammond food pantry, families at the Welcome Network, area seniors via Meals on Wheels, and absolutely anyone in need. We've learned based on the sheer quantity of donations, that this is not solely a food relief project but also veers into environmental work as we work to create less food waste in our community. This is a tremendous effort and would not be possible without so many hands and hearts.

Looking back we were happy to be able to complete both of our annual missions offerings: our One Great Hour of Sharing offering in the Spring and our Peace & Global Witness Offering in the Fall. And boy was this year a year of hands-on efforts! We planted our garden beds and delivered fresh produce to the families at the Welcome Network and had an outdoor ice cream social to get to know our new neighbors. In August we hosted a Household Supply Drive for the Welcome Network & NWI Veterans Village, in November, our annual Thanksgiving Food Drive supporting Greater Hamond and a Save Our Allies New with Tags Clothing Drive throughout December. And we also found time to arrange and complete a local mission trip to Sojourner Truth House to paint a room and hallway.

In a year of concern over events and extensive cancellations, we were able to pivot and offer outdoor opportunities to grow our team and understanding of the work we do via our September Get Into Gear taco truck event, Trunk or Treat community event and reinvisioned outdoor Bethlehem Market (including Giving Tree ornaments which prompted some great community conversations).

In November and December we hosted our annual Giving Tree effort: deciding on organizations, making ornaments, decorating the giant tree, staffing the table on Sundays and eventually taking everything down afterwards. We organized soup supplies and made soup for the Bethlehem Market, staffed tables to have a great safe community event and made memories together. We were happy to have the Christmas Eve offerings go to support Presbyterian Disaster Assistance for those affected by the tornados in Kentucky and Heart for Africa which had a year-end matching campaign. In a year when so many have been paring back, we've added more meaning and service. None of this would be possible without our generous community, so thank you for making 2021 so incredible. And stay tuned for another awesome year because we're already dreaming of how to tackle 2022 in new and creative ways.

COVID continues to impact the education system but the diligence of our preschool staff and families involved in the program has allowed us to maintain our operations for a second school year since the start of the pandemic. Things are slightly different but we continue to meet our mission of providing a safe and nurturing environment for the children entrusted to our care.

From January until May of 2021, we enjoyed the second half of last year's school calendar with a smaller clientele of five classes of 10 students in each class. We began the 2020-2021 school year with these numbers, which was about half of what we typically have, due to many people dropping out with COVID concerns. But we were able to keep our classroom open throughout that year and paid our salaries and bills without going into our savings.

As summer of 2021 approached, we saw that we would have more families registered for the 2021-2022 school year (our current year). Thus plans were made to open more classrooms and hiring of two additional teachers. We announced continued COVID mitigation efforts but offered more parent participation. Classroom aides, smaller classes at 10 max, drop off and pick up outside of door 2 and continued mask use were put in place. But parents were invited to participate in one of our 9 parties throughout the year and several outside fieldtrips and special events were placed on the calendar. As August arrived, we had 7 classes of 10 in place, two new teachers, several more aides, and we started the year with an in person parent orientation in South Hall.


The first half of the year went smoothly with day to day operations as well as a few fieldtrips and special events such as our Halloween parties, Thanksgiving feasts and Holiday parties. However, we did feel the effects of OMICRON Variant as we had staff

and families being impacted and did cancel one of our two days of Holiday performances. January begins our second half of the year and there is some anxiety over trying to keep everyone healthy and free of this new variant. I stay on top of the guidelines, contact tracing rules as well as the local case rates so our attitude has been to remain open each day we can manage within the parameters.

Despite the continued pandemic and the extra work involved in mitigation efforts, the preschool staff feels blessed to be able to serve the children and families of our community. We will continue with our mitigation efforts for the remainder of the school year and are excited to begin our enrollment process for next year in February.
